Property Overview

This ±28,077 SF three-story office building offers a high-quality, flexible environment ideal for professional, medical, or institutional users. Located just 3 minutes from I-69, the property is easily accessible and offers private on-site parking for tenants and guests in a quiet, professional setting.

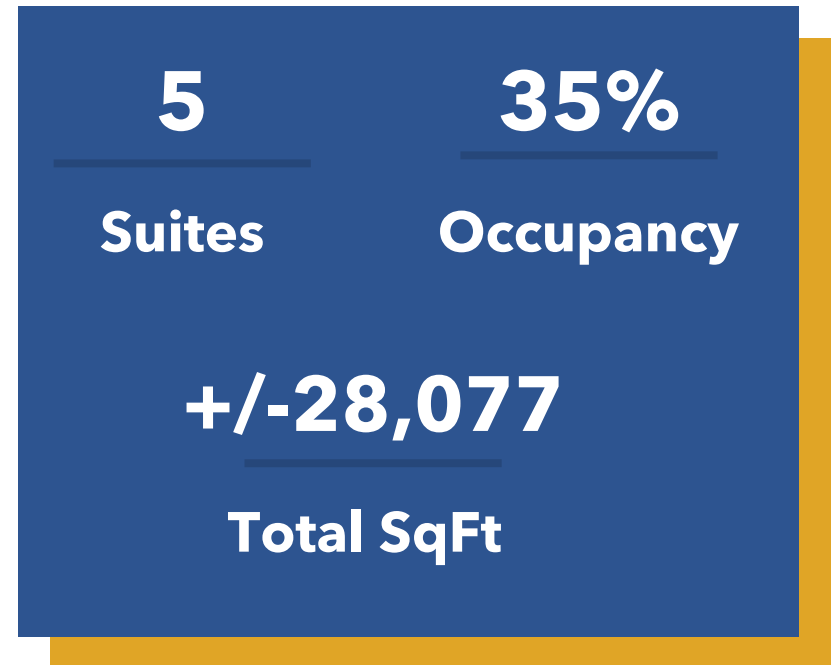
The main and lower levels each feature separate, handicap-accessible entrances, allowing for efficient multi-tenant use. The lower level includes two fully leased office suites, while the main level offers two office spaces and a large conference room. The second level, accessible by stairs only, is leasable and features a mix of cubicles and private offices. Each floor is equipped with kitchenettes.

Significant capital improvements have been made, including a \$220,000 solar panel installation, new chiller and HVAC units, and renovated tenant suites with modern upgrades—enhancing both operational efficiency and tenant experience. The building also includes Gas-powered backup electricity generators for power reliability.
